Friday, February 28, marks the fourth annual [HIV Is Not a Crime Awareness Day](#) (#HINACDay; #HIVIsNotACrime), a global effort to inform the public about unjust laws that target people living with [HIV](#) and the efforts to modernize those laws.

Today is #HIVIsNotACrime Awareness Day! Across the world, people living with HIV continue to be criminalised, discriminated against, and denied their rights. With shrinking resources and growing political opposition, the fight for justice has never been more urgent.

The HIV criminalization awareness day is spearheaded by [Sero Project](#), a nonprofit that fights HIV crime laws, along with [the Elizabeth Taylor AIDS Foundation](#) and other global HIV advocacy

For #HIVIsNotACrime 2025, the Sero Project released a six-minute trailer for the upcoming HIV criminalization documentary *To Be Free*, which highlights the strides made in Tennessee to modernize laws. It also profiles three women with HIV—Lashanda Salinas, Tiffany Moore and Michelle Anderson—who were successfully removed from the sex offender registry after helping change the state’s HIV laws. In related news, this week, CHLP (the Center for HIV Law and Policy) updated its [U.S. maps on HIV criminalization](#). Thirty-two states criminalize people living with HIV, and 28 states have harsh criminal penalty enhancements that elevate charges based on a person’s knowledge of their HIV status. For example, 11 states have penalty enhancements for people living with HIV who violate a general criminal law. [Learn more about the CHLP maps here](#). [HIV criminalization](#) refers to the use of unfair laws to target people who have HIV—notably, [African-American](#), [Latino](#) and [LGBTQ](#) people and [women](#)—and to punish them because of their HIV status, not because of their actions. Under outdated laws, people with HIV can be sentenced to prison in cases where HIV was not transmitted and their only crime was allegedly not disclosing their status.

It should be noted that repealing HIV laws does not mean that people can't be held accountable for intentionally transmitting HIV. Other laws may apply to the situation.

HIV is not a Crime Awareness Day is celebrated to expose the racial and LGBTQ+ disparities in HIV criminalization by emphasizing how these laws disproportionately impact Black, Latine, LGBTQ+, and low-income individuals. #HIVisnotacrime #newhavenpridecenter #lgbtq #queer #newhaven #ct

Many HIV laws were passed in the early days of the epidemic, when fear and lack of scientific knowledge about the virus reigned. Fast-forward four decades, and today we know, for instance, that people with HIV who take their meds and maintain an [undetectable viral load](#) do not transmit the virus sexually, a fact referred to as [Undetectable Equals Untransmittable](#), or U=U.
